### **USATF Rule of the Month**

### Rule 146.4

An immediate oral protest regarding a decision by the Starter to charge a false start, made by the competitor being charged, shall be accepted by the Start Referee. In order to protect the rights of all concerned and provide the time required to consider all evidence with regard to the charged false start, the competitor shall be allowed the opportunity to compete under protest, unless the evidence of a false start immediately available to the Start Referee is extremely obvious, in which case the protest shall be denied. After that decision, no further opportunity to protest that specifically charged false start shall be available to the competitor.

This will probably be called the Devon Allen rule. This rule has been sent to World Athletics for their consideration.

### NCAA/NAIA Rule of the Month

### **Point of Emphasis**

**Mixed Gender Competition Eliminated.** Mixed gender events are no longer an option for competition. Rules 1-45 and 9-45 were removed and are not included in this edition of the rules book.

**Five Alive Procedure Eliminated.** The five alive procedure in the vertical jumps is no longer an option for competition. Former Rules 1-27, 5=-4.3.d, 9-26 and 13-4.3.d were removed and are not included in this edition of the rules book.

Keep in mind NAIA may continue to run 5-Alive in their championships.

Be sure to not allow this to happen. Code of Conduct could come into play. **"Officials** Knowing rules and being just objective and courteous, while firm in enforcing rules. Acts of dishonesty, unsporting conduct or unprofessional behavior are unacceptable in track and field and cross country and subject to reprimand and/or removal by the referee or meet management."

### Minutes National Officials Committee Executive Committee Mid Year Teleconferencing Meeting March 7, March 14, & March 23, 2022

7:05 pm EST

The NOC Executive Committee Mid-Year Meeting was called to order by the Chair on March 7. The Mid-Year meeting will be conducted via a series of teleconferencing meetings.

The NOC Executive Committee members in attendance: Mike Armstrong, Gordon Bocock, Dick Boyd, Christopher Cummings, Mark Heckel, Robt. O. Kern, and Jamero Rainey. USATF Officials Coordinator: Conor Naughton.

A motion was made to adopt a floating agenda for the meetings. The motion was seconded and carried by unanimous vote.

A motion was made to adopt the Minutes of the NOC Executive Committee Meeting December 1, 2022. The motion was seconded and carried by unanimous vote.

### Chair's Report

The Chair provided updates on various topics, initiatives, subcommittees, and focus groups.

Chair Mike Armstrong, Vice Chair, Certification Jamero, Vice Chair, Training Mark, met via teleconferencing with NFHS Director of Sport, Julie Cochran, recently. The focus was the production of 5–10-minute Training videos for entry level officials. These would be "How to\_\_\_\_\_" videos. Gill will cover the production costs of the training videos which has the support and approval of the USATF National Office and the USATF Legal Department. Presently, topics, texts, and scripts are being formalized.

Focus groups on Women & Minority Officials are creating surveys to be emailed out to officials. Surveys to be available online about the end of May. The focus of the survey is to determine avenues to facilitate a greater involvement of underrepresented groups in USATF Officiating.

This year marks the 50th year of the NOC. Chair Mike Armstrong, Secretary, Robt. O. Kern, Treasurer, Christopher Cummings, and Officials Coordinator, Connor Naughton met recently with USATF Staff representing Entertainment, Merchandising, and Marketing. The focus was how to celebrate, publicize, and market this 50-year milestone in a cost-effective manner via videos, logos, and printed materials, etc.

The USATF 2023 Indoor Championship were held February 16-18 in Albuquerque, New Mexico. No protests involving officiating concerns were filed. Flexibility of officials to cover other areas made for a smooth and safe meet.



The WA protocols regarding sanctioning have been navigated at the NCAA level. An accelerated learning curve provided the necessary adjustments to adhere to the WA requirements.

The USATF Store has a surplus of white & red official's shirts. Strategies for their use were discussed as Navy Blue remains the USATF National Officials uniform shirt.

Applications were accepted for the position of Best Practices Editor. After a review of the applicants, the NOC has selected Greg Utecht (Minnesota Association). He will replace Richard Schornstein (Colorado Association) and continue the process of updating the Best Practices Library and keeping them up relevant.

### **Vice Chair Awards Report**

Vice Chair Awards, Gordon Bocock shared the 2023 implementation of the NOC Awards nomination process. The eleven Area Chairs, their 5 Certification Chairs, and the four At Large Representatives will nominate one person for each of the awards per area. This will result in a more manageable voting process.

#### Vice Chair Certification Report

The Vice Chair Certification, Jamero Rainey shared that as of March 7 we have 4,157 active officials and 337 officials in process. He will review to determine how come and why these officials have not completed their certification process.

2023 will also see a continuation of the 5 Certification Chair Teleconferencing Meetings. These regularly scheduled Association Certification Chair Meetings have been established to share information and assist in the understanding the many facets of Connect. To be proactive, these meetings are topical and relevant to the particular time of the year that they are held. Another topic with in Connect will be the changed or updated the search feature for finding officials.

Sending out of monthly files to Certification Chairs has been very helpful to maintain and increase officials' retention and support.

The recognition of Emeritus Officials standing is a step closer to becoming a reality.

### **Vice Chair Rules Report**

Vice Chair Rules Richard Boyd shared the process of creating new Rules Reviews for next Olympiad. At present several are complete, while others are in process. Alpha Testing will take place by February 2024 and Beta Testing by June 2024.

A discussion ensued as to the relevance of the Referee Review. Presently in the selection process, having referee certification is not a requirement and many referees are chosen/selected. In the USATF Governance Manual, it is a recommendation, but not mandated. Certification Chairs will be surveyed, by the National Certification Chair, to determine the relevance of the certification at the association and regional level. Further discussion is needed to come to consensus. Officials with Referee Certification will be surveyed as to the relevance of the certification in their duties.

### Training Report



The Vice Chair, Training Mark Heckel shared that the partnership with NFHS to produce the instructional videos is underway. A very aggressive timeline has been created and selected videos will be available by Spring 2024. NACAC will also be contacted and encouraged to become involved. This also presents a great opportunity for the NCAA to become involved with the training of officials and create a seamless presentation across all rule's constituency groups, NFHS, NCAA, and USATF.

EDM & EDR committees are moving forward and continue to fine tune the process and make it more cohesive, consistent, and codified. A pathway should be visible for all to see and work through towards certification. National opportunities should be made available for shadowing, mentoring, and hands on opportunities to ensure that the U-20 and National Championships have certified and qualified applicants, with the necessary skill sets. Presently we continue to certify officials in EDM & EDR Certifications, for those training situations that were preplanned and scheduled.

A discussion ensued on implementing the Coaches Education Model of providing Level 1 and Level training courses. Further discussion will be necessary.

There exists a necessity to present soft skills training. This will ensure that we produce officials to be the team leaders of the future. Utilization of technological learning could provide for some of the training...

### **Treasurer Report**

Treasurer Christopher Cummings reported that expenses and reimbursements are continuously taking place are now updated and reported to the National Office. They will all be resolved by the Annual Meeting.

The ledger is presently being reconciled and he is working to anticipate and proactively address needs and expectations. Presently the NOC manages and plans to utilize funds judiciously as the budget has remained consistent over the past several years. An investigation is taking place to determine where we can reallocate funds to better reflect our values, purposes, and goals.

### Secretary Report

The Secretary, Robt. O. Kern continues to provide updates to the NOC webpages and collaborate with appropriate individuals to facilitate ease pf operation for webpage reorganization. Delegates to the 2023 Annual Meeting will be identified in the Fall and details of voting will be provided to all NOC Voting Delegates. NOC members will receive timely and appropriate notifications concerning matters relative to the Annual Meeting prior to the event.

The Secretary will investigate listing all the Subcommittee Members on the web site, as we always strive to encourage as much involvement as possible. The logistics and mechanics of these types of postings will be investigated with Officials Coordinator Conor Naughton. The NOC Operating Procedures may need to be updated to provide the validity necessary for these types of posting. Further discussion is necessary.

### Evaluations

Subcommittee Chair Carolyn Hill reported that they are working to speed up the process of entering and maintaining an up-to-date database for evaluations. Matt Merrill is in a



learn by doing process to accomplish this task. She requests that more than one person have access to the database to set up and pull information.

Direction and information is needed concerning the mitigation process of moving the database and evaluation process to Connect or the new system being implemented.

Officials are reminded to submit their evaluations for the Indoor Championships that have been recently completed.

### **Uniforms and Equipment**

The Subcommittee Chair, Patty Mitchell, shared the several issues that they are moving forward on. They include working to make the Uniform website gender neutral, enforcing the current uniform guidelines, a proposal to change the current officials uniform, and requesting involvement in the discussion of the Officials Uniforms for LA28. In addition, they would like to see an increase in approved items to be added to the National Uniform section of the Officials Store.

Moving forward the subcommittee would like to increase the amount of direct interaction and communication with the National Office and NOC, to best serve the needs of officials and to facilitate and move uniform issues forward.

### **USATF NOC Officials Liaison**

NOC Officials Liaison Conor Naughton recently met with Merchandising to discuss the 50th Year of the NOC logos. Next week they will be meeting to discuss PSA and promotional videos to highlight the 50th Year of the NOC. The PSA would be played at national events.

Another official's promotional initiative could be the presence of an informational table at national events. A potential PSA could be the "Face of the NOC", short 30 second videos illuminating how officials became involved in track & field officiating and the intrinsic gratification they receive from officiating.

Discussion continues with the National Office on the integration of the USATF web pages and the NOC Dashboard web sites.

Evaluations and Applications prototypes, on Connect or the new system being implemented. Will be forthcoming in the next few weeks. The prototypes will be provided for review by the NOC.

A motion was made to recess the meeting at 9:48 pm EST, it was seconded and carried by unanimous vote.

**A motion was made and seconded to come out of recess,** at 7:08 pm, on March 4, 2023. The motion carried and the second session of the Mid-Year Meeting commenced via teleconference.



#### **Officials Grants**

Grant recipients have all been notified of their selection. All have applied and many have already been accepted to the various National Meets for 2023. The National Scholastic Outdoor requested that their meet be included as one of the selected meets for applicants to utilize. The NOC concluded the funds should be utilized at USATF National Championships.

For 2023, the National Youth and Masters Indoor Meets made their selection of officials prior to the Young Officials Grants being awarded, therefore limiting meets available. Financial disbursements are made immediately upon confirmation of award and selection.

Young Officials Grants presently are designed for officials aged 40 & under. The Vice Chair of Certification will report back with data, about the numbers of officials in this age category. He will also provide data concerning the numbers of officials' 45 years of age and younger.

New in 2023 is funding for the Apprentice Referee Program. The selected applicants are Angela Freeman and Lisa Colvin. Each of these officials will attend both the USATF Indoor & Outdoor Masters Meets. The NOC will reallocate funding to cover their grant support funds.

The Secretary will review the criteria for all grants received from the NOC. Identification of criteria is to ensures selection aligns with criteria.

### WA Technical Officials Subcommittee

In prior years WA Technical Officials were part of the Rules Committee. Now they are under the jurisdiction of the NOC. The Chair of the Subcommittee is appointed by USATF Chair and the USATF Governance Handbook outlines their duties.

In November of 2022, WA launched a new education certification system which also renames officials titles. Presently it is an online certification testing process with minimal pretesting support network. Plans are being made to provide supportive webinars for future testing. Martin Johnson (Colorado Association) has passed the initial certification process.

In February, a course and certification were offered for 1st time, for the role of NACAC - Technical Delegates. 4 USATF Officials individuals participated in the course and test in the Dominican Republic.

A handbook is being developed to outline the new roles, responsibilities, and pathway for obtaining certification.

#### **New Officials & Roundtable Meetings**

In 2023 Chair Mike Armstrong will again host a series of teleconferencing meetings, to continuously provide insight and support to new officials and ongoing training and discussions for all officials. Executive Board members will be able share the roles and responsibilities, provide insight into what we are and what we do, and provide a means for dialogue, interaction, and communication for officials.
